While scholars have illuminated various facets of "Laskar Pelangi," the exploration of social class dynamics within the novel remains an underexplored terrain. Existing studies, commendable in their depth, primarily focus on thematic elements, character development, and cultural nuances. However, the urgency of understanding how social classes are depicted and function within the narrative has yet to receive the scholarly attention it deserves. This study aims to rectify this oversight by plunging into the uncharted waters of social class within "Laskar Pelangi."

The first paper (Kadir, 2013); Wahyudin & Harjanto (2023) examine the expression of the author's social group worldview in Andrea Hirata's novel Laskar Pelangi. The paper uses a genetic structuralism theory approach and finds that the novel emphasizes the importance of social harmony and mutual respect among different ethnic groups.

The second paper, (Yuliantoro, 2018) uses the film Laskar Pelangi as a case study to explore how pragmatism is practiced in education in Indonesia. The paper finds that the main characters in the film experience dilemma situations that lead them to choose a way of life based on internal logic and actual experience. The paper also criticizes pragmatism for its potential to lead to individualistic thinking.

The third paper (Hidayat, 2018) examines the construction of educational discourse in the novel Laskar Pelangi. The paper argues that the novel's focus on education has contributed to its popularity and has helped to mobilize communities around the issue of education.

The fourth paper by Sofia (2017) examines the impact of tourism on the identity and social-religious interactions of the Belitung people on Belitung Island. The paper finds that the island has experienced economic acceleration since the release of the Laskar Pelangi film, but that this has also led to changes in the Belitung's identity and social-religious interactions.

Overall, these four papers provide a variety of perspectives on the novel Laskar Pelangi and its impact on Indonesian society. They raise important questions about the role of literature in education, the impact of tourism on local communities, and the importance of social harmony and mutual respect.

Martono (2010) article provides a sociological analysis of the Indonesian education system, critiquing its practices through the lens of the film "Laskar Pelangi" (Rainbow Troops). The paper explores the conflicting functions of education, emphasizing both its role in transmitting values across generations (functional perspective) and its contribution to social inequality (conflict perspective). The analysis delves into various criticisms, such as the formalization of education, the exclusivity of school functions, inequality in access, and the dichotomy of favourite schools. Martono (2010) concludes that these dynamics contribute to social inequality in national education.

Muthmainnah (2016) research focuses on the motivations for learning presented in the novel "Laskar Pelangi." Using descriptive research methods, the paper addresses literary elements,

motivations in learning, the author's reasons for incorporating these motivations, and the implications for readers. The study identifies figurative language usage, with the main character being Ikal. Learning motivations in the novel include enriching knowledge, pursuing dreams, and winning competitions. The author, Andrea Hirata, is revealed to have used learning motivation to break stereotypes and motivate learners. The implications for readers include motivation to study abroad and admiration for life, as inspired by "Laskar Pelangi."

Akun's (2011) study explores postcolonial themes in Andrea Hirata's "Laskar Pelangi," highlighting hybridity as a characteristic that categorizes the novel as postcolonial despite the absence of Western colonialism traces. The paper argues that the novel serves as a counter-discourse, criticizing the domination of certain groups over marginalized individuals in the context of Indonesian national issues. Education is portrayed as a global problem within local culture and mysticism, reflecting an ironic perspective.

Budiati et al., (2023) paper explores politeness in "Laskar Pelangi" the movie, focusing on sentential implicature and cooperative politeness. The analysis considers maxims such as tact, approbation, generosity, modesty, agreement, and sympathy. The study identifies cultural background elements in Indonesian politeness, such as addressing individuals by name or title based on power and relationship. Politeness is depicted through indirect mention and the avoidance of dispraise, showcasing how these cultural aspects influence communication in the film.

Kuncara's (2017) paper evaluates the translation of cultural terms in the English version of Hirata's "Laskar Pelangi," examining its impact on translation quality. The research categorizes cultural terms into ecological, material, social, organizational, custom, idea, motion, and habit. The findings suggest that the translation of cultural terms reduces the acceptability and readability of the translated work. The study sheds light on the challenges and implications of translating cultural elements, emphasizing the importance of maintaining the integrity of cultural nuances in the translation process.

Kish-Gephart et al., (2023) study social class and work. This paper addresses the recent surge in interest in the topic of social class within organizations. The authors identify a lack of indepth understanding due to the fragmentation of research across disciplines. The study reviews over 400 articles, providing a comprehensive framework for organizing social class research. It emphasizes the institutionalization of social class distinctions in organizations and calls for future research to bridge disciplinary gaps.

On the other hand, Côté (2011) studies how social class shapes thoughts and actions in organizations. This chapter explores into the influential role of social class in shaping individuals' thoughts and actions within organizational contexts. It defines social class as rooted in objective material resources and explores its impact on social relationships, morality, and decision-making. The author discusses the risks and benefits of investigating social class in organizations and underscores the potential consequences of overlooking this factor.

The psychology of social class was done by Manstead (2018). The author argues that material conditions significantly influence personal and social identities, shaping thoughts and feelings about the social environment. The article highlights differences between lower/working-class and middle-class individuals in self-concept, explanatory styles, empathy, and behaviour. It challenges stereotypes and emphasizes the need for redistributive policies to address social class-related challenges.

Power, Group Dominance, and Societal Change will fall when inequality fails (Pratto et al., 2013). This study revisits social dominance theory, exploring aspects that allow for societal alternatives and change. The authors expand the traditional three-level dynamic system to four levels, identifying political tensions as unstable power structures. The paper suggests that social dominance theory has limitations in explaining societal change and considers alternative forms of social organization.

The psychological study of class consciousness, focusing on class consciousness, this study introduces a psychological model comprising five elements (Keefer et al., 2015). It assesses awareness of social class, perceptions of class conflict, beliefs about class permeability, identification with a class group, and personal experiences of being treated based on class. The study explores differences across demographic and political variables, contributing to the understanding of class consciousness.

The rise of income and the demise of class and social status (Barone et al., 2022) examines trends in measuring socio-economic position in stratification research. It finds that income measures dominate and are increasing in prevalence over class and social status measures. The study discusses the implications of these trends for sociology, signalling potential shifts in the focus of social stratification research.

Wyatt-Nichol et al., (2011) study Social class and socioeconomic status. It focused on public administration, this article explores the relevance of social class and socioeconomic status to social equity. It emphasizes the impact of increasing income inequality on economic segregation and public service delivery. The study advocates for scholars to promote social equity through representation, research, and pedagogy.

The study examines changes in how people define social class over four decades and between ethnic groups (Cohen et al., 2017). The findings indicate shifts in the importance of income and occupational prestige. The article discusses the implications of these changes and highlights differences in subjective status perceptions among various racial and ethnic groups.

The study of associations of social class and social stratification with patterns of general and mental health in a Spanish population uses Erik Olin Wright's indicators of social class position to examine their association with self-reported general and mental health (Muntaner et al., 2003). The findings suggest that social class taps into aspects of social variation not captured by conventional measures of social stratification and education. The study emphasizes the health consequences of power relations within the labour process.

These studies above collectively provide a rich understanding of social class from various perspectives, including organizational dynamics, psychological effects, societal change, class consciousness, and health implications. They contribute to the ongoing discourse on social class, offering insights into its multifaceted nature and relevance across different domains of social life.
